

## COOKIE POLICY

As TUSAŞ ENGINE INDUSTRIES, INC. (hereinafter referred to as “**Company**” or “**TEI**”), we use some technologies (“**Cookies**”) such as cookies, pixels, gifs to improve your experience during your visits in our online media. The use of these technologies is carried out in accordance with the legislation that we are subject to, especially the Personal Data Protection Law No. 6698. These technical communication files, called cookies, are small text files which a website sends to the browser on a user's computer or mobile phone.

The purpose of this Cookie Policy text is to inform you about the processing of personal data obtained during the use of cookies by the Website users and members (“**Data Subjects**”) during their visit at [www.tei.com.tr](http://www.tei.com.tr) (hereinafter referred to as “**Website**”). In this policy, we would like to explain to you what kind of cookies we use for what purposes and how you can control these cookies.

As a company, we can opt out of using the cookies we use on our site, change their types or functions, or add new cookies to our site. Therefore, we reserve the right to change the provisions of this Cookie Policy at any time. Any changes made to the current Cookie Policy will become effective when they are published on the site or in any public medium.

### 1. For What Purpose and How Are Cookies Used?

[www.tei.com.tr](http://www.tei.com.tr) and the websites of the Company's business partners aim to provide users with personalized content, campaigns and advertisements in line with their interests and needs. This is to improve the website experience by preventing unnecessary ad impressions, which would not interest the user. In this context, cookies both help us to recognize you and make the Website more useful and helpful for you with content, advertisements and campaigns that we think will interest you.

- Cookies can be used on the websites of other business partners who wish to use this Website.
- Cookies may be used to show ads and campaigns, which may be of interest to you when you enter the Website, and to determine whether you are interested in this ad after seeing content and an ad on the Website, and whether you are visiting the website of that product or service.
- Cookies can be used to perform basic functions required for the operation of the Website.
- Cookies may be used to create statistics such as the number of users visiting the Website, user type, frequency of visits, user behavior and habits, the countries from which the users visit the website, etc.

## **2. What Information Is Received and Processed Through Cookies?**

The movements such as the websites visited before and after the Website, the geographic location of the users, their reactions to the advertising banners on the website, the personal information that the user has given to the Website and the websites of its business partners, preferences made on the Website, social Actions regarding the Website and the websites of our business partners can be received and processed. Data received from different websites can also be combined and processed.

The information you have provided to the Website and the websites of business partners can be received and processed by the Website or its business partners for the purposes specified here.

## **3. What Are the Cookies Used On Our Website?**

Below you can find the different types of cookies we use on our Website. Cookies used on our Website can generally be classified as follows:

- **Necessary Cookies:** These cookies are essential to ensure the correct and proper functioning of our Website; they allow you to navigate our Website and use our features. Examples of this include remembering previous actions (for example, previously entered text) when navigating back to a page in the same session. These cookies do not recognize you and do not identify you as a separate person. If you do not accept these cookies/permissions, this may affect the performance of the Website.
- **Performance Cookies:** These cookies collect information about how you use our Website, including, for example, which pages you go to most frequently, how much time you spend on our Website, and problems you encounter, such as error messages. These cookies are also used to ensure that affiliated companies find out whether you come from a source affiliated with another person or an institution and whether you have purchased any of our products or services as a result of your use (including details of the product or service you have purchased) or whether you are using any of our products or services. This helps us increase and improve the performance of our Website. These cookies do not recognize you and do not identify you as a separate person. All information collected by these cookies is combined, which makes them anonymous. These cookies are used only to improve the operation of our Website.
- **Functionality Cookies:** These cookies allow our Website to remember your choices and preferences (information such as your username, language or region) in order to provide you with a more personalized internet experience. The information these cookies collect may include personal data and information that you have disclosed. If you do not accept these cookies, your choice may affect the performance and functionality of our Website and may restrict your rights to access content on our Website.

- Thanks to the "Google Analytics cookie", we can get considerable amount of information about how you use our Website. Google Analytics provides us with the information we need to improve the experience of our Website and deliver the content you find most useful. Google Analytics cookies record detailed information about which pages you visit on our Website, how much time you spend on our Website, where and how you accessed our Website and which content you clicked. Thanks to the information provided by Google Analytics, we can examine the flow on our site, identify areas that need improvement and provide you with a much better experience. Google Analytics cookies do not collect and/or store personal information of users. Therefore, this information cannot be used to identify individuals.

#### **4. Duration of Cookies We Use**

In terms of time, we may use two different types of cookies on our Website:

- Session Cookies: These cookies are temporary cookies that remain on your device until the time you leave our site.
- Permanent Cookies: These types of cookies remain on your device for a much longer period of time or until you manually delete them. How long the cookie will remain on your device depends on both the lifetime of the relevant cookie and your personal device settings.

#### **5. Compliance with Legal Regulations**

The website and business partners of the Company may not act for any purpose which are not lawful or other than those specified here. This practice is updated in line with the amendments in the legal regulations to comply with the form and scope determined by the law.

#### **6. What Are Your Rights as a Data Subject?**

In accordance with Article 11 of the Personal Data Protection Law, data subjects have the rights;

- To learn as to whether personal data has been processed or not,
- to request information if his personal data are processed,
- To learn the purpose of processing personal data and whether they are used in line with their purpose,
- To know the third parties to whom personal data are transferred in the country or abroad,
- To request correction of the personal data processed incompletely or inaccurately and to request the provision of the information on the transaction performed under this scope to the third parties to whom the personal data are transferred,

- To request the deletion or destruction of her/his personal data and to request the provision of the information on the transaction performed under this context to third parties to whom such personal data are transferred, where reasons for processing personal data are disappeared, although these are processed in accordance with the provisions of Law on PDP and the relevant provisions of other related laws,
- to object to consequences to her/his detriment, arising from the analysis of the processed data exclusively via automatic systems,
- To claim compensation in case of suffering loss due to illegal processing of the personal data.

If you send your requests regarding your rights using the methods specified in the "**Relevant Person Application Form**", which can be found at [www.tei.com.tr](http://www.tei.com.tr), your applications will be evaluated and concluded as soon as possible and within 30 (thirty) days at the latest. Although it is essential that no fee is charged for the requests, the Company reserves the right to charge a fee over the fee schedule determined by the Personal Data Protection Board.

The Data Subject agrees, declares and undertakes that s/he may not be able to fully benefit from the operation of the Website in the event that s/he makes a request that will result in the inability of any personal data to be used by the Company, and that any responsibility arising in this context will belong to him/her.
